**THIS EXAMINATION IS GIVEN TO FILL SUMMER 2026 SWIMMING POOL POSITIONS ONLY**

**SALARY:** \$35.05/hour (The current salary is subject to change. You may confirm the starting salary with the hiring department before accepting a job offer).

**DUTIES:** Supervise the operation of a municipal pool; train and supervise aquatic facility staff; act as a lifeguard; develop, promote, direct and conduct pool programs in swimming, lifesaving, swim team, springboard diving, synchronized swimming, and water polo; enforce rules, policies and codes related to municipal swimming pool operations.

#### **REQUIREMENTS:**

**1. EXPERIENCE:**

- Two (2) full summer seasons paid experience as a Pool Manager I with the City of Los Angeles; and,
- **American Red Cross Lifeguard Management** – online course - Due by May 29, 2026; and,
- Attend all mandatory manager training and maintain an LA City Lifeguard Certification.

**2. AGE:** 18 years of age by May 25, 2026. Proof of age with picture ID **will be required** at the interview.

**3. CERTIFICATION:** **Proof of American Red Cross Lifeguard Management** – online course is required and must be uploaded to <http://bit.ly/CWATrainingSurvey> by May 29, 2026.

**4. EXAMINATION:**


**ORAL INTERVIEW:** Weighted 100%; a minimum score of 80% is required to be placed on the eligibility list.
