## RECOMMENDATIONS

- 1. Approve the scope of work and the total budget of the Watts Senior Citizen Center Roof and HVAC Replacement (PRJ21899) Project (Project), as described in the Summary of this Report;
- 2. Authorize Department of Recreation and Parks (RAP) staff to commit, from the fund and work order numbers listed in Attachment 1, a maximum of \$1,007,436.40 in Park Fees for the proposed Project;
- 3. Approve the Project to be bid and constructed through the RAP list of pre-qualified on-call contractors;
- 4. Approve the authorization of change orders as authorized under Board Report No. 06-136, for the construction contracts for this Project in the budget contingency amounts for such contracts as stated in this Report;
- 5. Determine that the Project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article 19, Sections 15301(a) [Interior or exterior alterations involving such things as interior partitions, plumbing, and electrical

conveyances], 15301(c) [Existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities], and 15302 [Replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity] of California CEQA Guidelines and Article III, Section 1, Class 1(1), Class 1(3), Class 2 and Class 2(6) of City CEQA Guidelines, and direct RAP staff to file a Notice of Exemption (NOE) with the Los Angeles County Clerk and the Governor's Office of Land Use and Climate Innovation;

- 6. Authorize RAP's Chief Accounting Employee to prepare a check to the Los Angeles County Clerk in the amount of \$75.00 for the purpose of filing an NOE; and,
- 7. Authorize RAP staff to make technical corrections as necessary to carry out the intent of this Report.

## SUMMARY

Watts Senior Citizen Center is located in the Watts community of the City. This 1.30-acre recreation facility provides a senior center, auditorium, community room, multipurpose room, gazebo, and fitness equipment for the use of the surrounding community. Due to the facility's size, features, program and the services it provides, the Watts Senior Citizen Center meets the standard for a Community Park, as defined in the City's Public Recreation Center Plan.

#### PROJECT SCOPE

The scope of work of the Project involves the following:

- Replacement of the roof and HVAC system of the senior center
- Parking lot asphalt resurfacing
- Replace and restore interior floors

## PROJECT FUNDING

Upon approval of this Report, \$1,007,436.40 in Park Fees can be committed to the proposed Project, which is the total budget including budget contingency. See below the anticipated pre-qualified on-call contract(s) and budget contingency amount(s) that will be used for the Project:

## TREES AND SHADE

The proposed Project has no impact on the existing shade and trees at Watts Senior Citizen Center.

## **ENVIRONMENTAL IMPACT**

The proposed Project consists of interior and exterior alterations involving negligible or no expansion of existing or former use, minor alterations of existing streets and similar facilities, and replacement of existing structures where the new structures will be located on the same site as the structures replaced and have substantially the same purpose and capacity.

According to the parcel profile report retrieved on November 13, 2025, this site is within the liquefaction zone, but the proposed Project will not increase the risk of liquefaction in case of an earthquake. The site is not within a coastal, methane, or historic protection zone, so there is no reasonable possibility that the proposed Project may impact on an environmental resource of hazardous or critical concern or have a significant effect due to unusual circumstances. No other known projects would involve cumulatively significant impacts, and no future projects would result from the proposed Project. As of November 13, 2025, the State Department of Toxic Substances Control (DTSC) (Envirostor at www.envirostor.dtsc.ca.gov) and the State Water Resources Control Board (SWRCB) (Geotracker at https://geotracker.waterboards.ca.gov/) have not listed the Project site. They listed case ID 60003304 near the Project area (within 1,000 feet); this case concerns a dry-cleaner that operated in the area from 1927 to 2022. Soil investigations show several contaminants at concentrations exceeding screening levels for residential and commercial land use. Given the distance from the site, this case does not constitute a threat to the patrons of the Senior Center. According to the Caltrans Scenic Highway Map, there is no scenic highway located within or adjacent to the Project site. Furthermore, the proposed Project is not within an historic site and will not have any significant effect on historic resources.

Based on this information, staff recommends that the Board of Recreation and Park Commissioners (Board) determines that the proposed Project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article 19, Section 15301(a), 15301(c) and 15302 of California CEQA Guidelines and Article III Section 1, Class 1(1), Class 1(3), Class 2 and Class 2(6) of City CEQA Guidelines. Staff will file a Notice of Exemption with the Los Angeles County Clerk and the Governor's Office of Land Use and Climate Innovation upon Board's approval.

## FISCAL IMPACT

The approval of this commitment of Park Fees will have no fiscal impact on RAP's General Fund. The estimated costs for the design, development, and construction of the proposed park improvements are anticipated to be funded by Park Fees, or funding sources other than RAP's General Fund. The maintenance of the proposed park improvements can be performed by current staff with minimal impact to existing maintenance service at this facility.
