Monday, June 9, 2025

CALL TO ORDER

APPROVAL OF THE MINUTES

President Simril called for a motion to approve the minutes of the Regular Meeting of May 1, 2025. Vice President Sanchez made such motion, and it was seconded by Commissioner Hutton. There being no objections, the motion was unanimously approved by a vote of 4-0.

GENERAL MANAGER'S UPDATE

Matthew Rudnick, Executive Officer, who is filling in in the absence of Jimmy Kim . Mr. Rudnick began his update with a message from General Manager Jimmy Kim that was shared with all staff. "I am writing you today because of the growing concerns in our communities about Federal immigration enforcement activities, these activities are understandably creating fear and uncertainty for many of our patrons and we recognize a direct impact in participation in programs. As of Recreation and Parks our fundamental is to ensure that our facilities remain safe, welcoming and inclusive. For every Angeleno and visitor. Parks, recreation centers and programs are vital. Community hubs. All individuals regardless of immigration status, should feel supported and secure. Our strength lies in our unity and in our commitment to the diverse communities we serve.

Mr. Rudnick introduced Traci Goldberg, Superintendent of Valley Region Recreation Services Branch. Traci provided an introduction of the facility and staff at Lake View Terrace Recreation Center.

Mr. Rudnick made announcements of new staff assignments. Acting Superintendent of Recreation Operations for the Pacific region, Kimberly, Simonet. Acting Superintendent of Maintenance Operations for Metro Griffith Valley and Forestry, Wayne Neal. Acting Superintendent of Maintenance Operations, Pacific West and homeless response services, Robert Buenostro

Mr. Rudnick provide an update on the Budget. He stated the proposed budget for RAP included 192 full-time position eliminations which was the equivalent of a roughly 15 million dollars salary reduction. Additionally, the proposed budget proposed to cut a roughly 6 million dollars of expense funding, including overtime, hiring hall and supplies. The proposed budget was amended by the City Council. And we were able to restore roughly 129 of those full-time position reductions leaving a total of 63 position eliminations.

Mr. Rudnick mentioned that our Summer Camp and summer sports programs and our summer swim session is in full swing.

Mr. Rudnick introduce Michael Zambrano from the CAO's office to provide an update on the performance metrics and operation for ABH Riverside He also introduced Patrick Siggins, Director of Homelessness services from Council District 4 to speak on the ongoing programming and continued success we are seeing with the ABH Riverside Ambassador program.

Jessica a Landscape Architect provided an update on the Park Needs Assessment.
