SUMMARY OF NEW AND CURRENT BUSINESS ITEMS**

**March 16, 2023**

Griffith Park Train Ride Easter Event

- The event will take place at the existing train ride located on Crystal Springs Drive and will feature Easter-themed exhibits along the train ride, prizes for patrons, photo opportunities and appearances by the Easter Bunny. Tickets for the train ride will be \$5 and photo opportunities with the Easter Bunny will start at \$7.

RFP Update

- An RFP for Sherman Oaks Castle Park Snack Bar and Arcade will be released later this month. The RFP combines the two operations into one contract. Staff will conduct extensive outreach and ensure that minority-owned businesses are included in that effort.

Rancho Park Golf Clubhouse Renovation Update

- Demolition work is scheduled to begin in early April. The switchgear delivery date is driving the project and has been delayed due to production issues. Therefore, the estimated completion date is now February 2024.

Griffith Park Pony Ride

- Staff is in the process of obtaining a consultant as discussed at the previous Task Force on Concessions meeting.
- Community engagement efforts are on ongoing.
- Signs have been posted at the premises that provide the community with information along with email and telephone contact information for submitting comments or questions.
- Business continues to be very slow for the neighboring Train Ride and Snack Stand concessions.
- A one-year Right of Entry Permit is being drafted for the GP Train Ride Operator to temporarily use the birthday party corrals that were vacated by the pony ride operator.

Sherman Oaks Castle Park Snack Bar

- After being closed throughout the pandemic, an interim operator will reopen the snack bar in April. The operator is a joint venture between the existing concessionaires who operate the arcade and batting cages, and they will operate the concession until a new contract is awarded resulting from the RFP process.
