Monsignor Ramon Garcia Park - Playground Replacement Project - Donation and Donor Plaque

Request: RAP is requesting the approval of the project concept, proposed donation, and proposed donation recognition plaque.

Project Background: Monsignor Ramon Garcia Recreation Center is located at 1016 South Fresno Street in the Boyle Heights community of the City and in Council District 14. This 6.49-acre facility provides a recreation center building, two ball diamonds, a basketball court, a children's playground, and picnic tables. An estimated 6,396 City residents live within a one-half mile walking distance of the park.

Scope of Work: The children's playground at Ramon Garcia Recreation Center is in need of replacement. The playgrounds is located on the western corner of the park, near the intersection of Fresno Street and Atlantic Street. The proposed project would include the demolition and replacement of the existing children's playground in the same location.

Project Budget and Funding: At this time the total estimated cost of the project is \$510,000.

Proposed Donation: The Werner Family Foundation is proposing to donate a total of \$465,000 in funding to the Los Angeles Parks Foundation for this project. RAP would provide any additional funding necessary to implement the project from the Deferred Maintenance funding that RAP recently received from the City in the Fiscal Year 21-22 Budget.

Proposed Donor Recognition Plaque: The proposed donor recognition plaque would be no larger than 18"H X 24"W. The plaque would be made of bronze. A location of the plaque has not yet been determined. The proposed language for the plaque is:

Community Outreach/Input: The concept design of the playground was shared with the Facility Directory, who has also shared it with various community members including with some members of the Park Advisory Board. Feedback was received on the proposed colors of the playground, and the community decided they want the playground to be yellow and red with blue shade toppers so that the playground was bright and colorful for children.

Trees and Shade: The proposed Project will not have any impact on the existing trees and shade at Ramon Garcia Recreation Center. The proposed new playground will have integrated shade toppers that will provide more shade than the current playground provides
