## Confirmation Packet Form

Furthermore, I understand that if I do come to camp during non-designated times, I will be required to take my child home immediately.

I have read and understand the medication policy which states that each medication must be in its original container and package with the dosage instructions in English, and that this includes prescriptions, non-prescription/ over the counter medications, inhalers and vitamins. I understand that only the camper named on the original prescription may be given that medication. I understand that a signed Request for Medication must be filled out for every medication, vitamin, prescription cream etc. in order for my child to take it while at camp.
